One of the three main roles of governors is to ensure clarity of vision, ethos and strategic direction. Ofsted will wish to see how the governing body works effectively with leaders to communicate their strategic direction for the school and develop a culture of ambition. During this session we will explore what makes a good strategic plan. We will look at who writes it, how the content is obtained, how the governors' vision is best communicated and how the School Development Plan sets out how the vision will be delivered.

We will then explore how we must ensure that our school improvement plan is being delivered in a timely manner.
