#### **Your Service Level Agreement 2023**

As a Diocesan Education Team we are keen to provide an efficient and relevant service which adds value to the work undertaken in Trusts and schools to improve the life chances of the children and young people in our care.

This document sets out some of the ways in which we can offer you support through our diocesan funded **core offer** (see appendix 1), **Service Level Agreement** (**SLA**) **subscription service** and through a **'Pay As You Use'** route. We intend to make our offer truly personalised and bespoke so we will tailor our support with you when you subscribe to the SLA. We are keen to meet your Trust's and schools' specific needs and acknowledge the changed circumstances and challenges currently being faced. We look forward to continuing our work together and to serving your schools' communities in the most appropriate way.

Trust and/or school support and visits will be undertaken by one of our team or by an Associate. As the Diocesan Education Team, we have extensive experience and knowledge of church schools including in leadership, governance matters, SIAMS, Collective Worship, Religious Education and school organisation. We work with 17 different Multi-Academy Trusts with church articles within the Diocese of Exeter, and additionally with others who have mainstream articles. Our Associates are all current school leaders or will have recent relevant experience.

Trusts can organise their support in any way they wish. Some do this by focussing on trust wide priorities for training, school development and improvement, for example by bringing together Heads, RE leads or Ethos groups, or by working with us as the central team. Other Trusts request we work with individual schools. It is your choice, and we will endeavour to tailor our work to your specific requirements.

# Service Level Agreement Packages

Through our subscription service, you can purchase support that is in addition to our diocesan funded core offer, outlined in appendix one (on page 10).

Trusts are invited to select one of the following support packages. Please see pages 5-7 for a description of the different activities. The sharing of activities and training events in MATs is encouraged. It can be very effective to pull together your Heads, RE leaders, Collective Worship/ Christian Distinctiveness leaders or ethos groups/committee members to work on strategic priorities together, or to bring together your staff and/or governors for a shared training session.

#### **Standard Package:**

Up to 4 activities (delivered over 2 days\*)

#### **Enhanced Package:**

Up to 6 activities (usually delivered over 3 days\*)

Our support for Trusts, with church school articles, aims to help them fulfil the second part of their 'object' so that schools designated as Church of England are 'conducted in accordance with the principles, practices and tenets of the Church of England both generally and in particular in relation to arranging for religious education and daily acts of worship'. Additionally, we can support individual or groups of schools with their distinctiveness and effectiveness as a church school.

Our Standard Package includes all our core offer and additionally Trusts can choose four activities from the range of:

- ✓ School development activities
- ✓ Critical friend reviews
- ✓ Recruitment and induction activities
- ✓ Training events

Trusts should organise two of the activities into a full day visit\*\*. In addition to the delivery of activities, we will provide all necessary activity preparation and a written report.

Our Enhanced Package provides more time for your Trust's support. It includes all our core offer and additionally Trusts can choose six activities from the range of:

- ✓ School development activities
- ✓ Critical friend reviews
- ✓ Recruitment and induction activities
- ✓ Training events

Trusts should plan to implement two activities into each full day visit\*\*. In addition to the delivery of activities, we will provide all necessary activity preparation and a written report.

<sup>\*</sup>A half day visit is defined as three hours, whilst a day visit is defined as 6 hours.

<sup>\*\*</sup>or equivalent. This might include an afternoon activity followed by a twilight training event. We are asking schools to combine activities as we are mindful of using our time efficiently and also reducing the environmental impact of our travel.

### Subscription Service Activities

Our services have been organised into four different types of activity, and Trusts can select from these to ensure the support is tailored to their needs.

- Our **development activities** are intended to help your MAT develop an aspect of your provision. We will work in partnership with you to plan and offer a bespoke service to meet your needs.
- Our critical friend reviews are intended to help you check and verify whether your own selfevaluation is accurate. In these visits, we offer an external perspective and would request key information from you prior to the visit. We would use the visit(s) to carry out joint monitoring and evaluation to help confirm your judgements and to inform your Trust's or individual schools' improvement planning.
- Our **recruitment and induction activities** are to support any additional recruitment, other than that covered in the core service. This could be support for recruitment of key personnel, such as members of your leadership team or other key roles in your Trust. You could use your subscription to ensure all new senior staff have an in-depth induction into church school leadership.
- Our training events can enable your staff groups to be trained together, from across your trust, ensuring that everyone has access to our expertise and best practice can be shared and celebrated. Training can be tailored to Trust staff, governors, ethos committees, pupil groups or volunteers. Leaders or groups of teachers or ethos committee members could be bought together to improve an aspect of provision across all the schools.

#### **Development Activities**

A half-day activity\* to focus on enhancing the Christian Foundation of the school(s) in the MAT. This will include working with Trust leads, Heads, RE and Collective Worship leaders and governors to ensure that leadership is effective at improving the Church school provision. These development activities may provide guidance, advice or support on any of the following:

- Christian Vision and Distinctiveness
- Religious Education
- Collective Worship
- Character Education
- Governance
- Admissions
- Church school leadership, including subject leadership
- Spiritual, Moral, Social and Cultural Education
- Valuing all God's Children: Developing your provision for Equality, Diversity and Inclusion
- Chaplaincy development
- Partnership with your parish
- Courageous Advocacy

### Subscription Service Activities

#### For example, the Trust development visit could focus on:

- Support for your MAT leaders, Heads or subject leaders/ Heads of Department in developing an aspect of RE, Worship, SIAMS, Christian distinctiveness or Character Education
- Working in partnership with your RE department to support development of planning, teaching and learning or assessment.
- Assistance with writing SIAMS Self-Evaluation Documents or an area of your Improvement Plan
- Post SIAMS action planning
- Joint RE lesson observations or work scrutiny, with strengths and areas for improvement identified
- Pupil conferencing
- Support of the work between schools and parishes / mission communities
- Support for Directors or local governance in embedding monitoring of the Christian distinctiveness of the Church school(s)
- Support for chaplains
- Post governance review action planning

#### **Critical Friend Reviews**

A half-day visit\* in the Trust or an individual school to provide a review of the self-evaluation linked to the second part of your 'object' and/or the SIAMS schedule. It is good practice for a Foundation Director to be present, and where focussed around an individual school, for the incumbent and/or a local foundation governor to be present. This review will enable Trust and/or school leaders to work in partnership with an Education Advisor to check and verify the Trust/school's own self-evaluation. For a more thorough review, you might consider combining two or more of your activity sessions.

You might also use a 'Critical-Friend Review' to 'deep dive' an aspect of MAT wide provision e.g. a scrutiny of RE books from across the trust.

#### The review may focus on:

- How Christian vision is understood and its impact on pupils and adults across the school/Trust
- SIAMS SEF judgements, drawing on a range of available data
- Progress towards school/Trust improvement priorities
- A deep dive into an aspect of Church school provision e.g. RE or Collective Worship
- Effectiveness of governance in monitoring to ensure the Christian Foundation of church schools and the second part of your 'object' is upheld

#### **Recruitment and Induction Activities**

We can support recruitment of your key personnel, such as senior leaders, or for trust roles such as Christian Distinctiveness Lead. We are able to provide induction support for colleagues that are new to working in Church schools, provide targeted advice relating to your own Trust and schools' context and links with parishes/mission communities. In Trusts, we can host meetings for all new Church school leaders to help with induction into their role.

- Visit to support a new Trust Christian Distinctiveness lead or Head within their own context
- Engagement with staff appointments shortlisting and interview advisory support
- Induction events in school or pooled together for school staff
- Support for Early Career Teachers welcome to your Church School

#### **Training Events**

If you subscribe to either the 'standard or 'enhanced' service level agreement, you are able to select one or more training events from a range of training options, delivered in one of your schools, for staff or Ethos groups/committee members or Governors, drawn from across the trust. The following training and development opportunities are examples of what can be included as an optional element of the subscription service:

- Thinking Governance Programme developed by the Education Office of the Church of England to contribute to better governance, for example by enabling boards to consider their 'strategic picture'.
- Training for responding appropriately to bereavement and loss.

- Equality, Diversity and Inclusion awareness training, drawing on 'Valuing all God's Children'.
- 'Trauma Informed Schools' training
- Governance Board personalised training
- Training for Ethos group or committee development
- Inset day training
- Developing Spirituality training
- Training or planning advice tailored to the implementation of units from the agreed syllabus – Christianity or other faiths.
- Philosophy for Children (P4C)
- Collective Worship
- Courageous Advocacy

You will be able to purchase support to meet your needs, such as that outlined in the 'standard' or 'enhanced' services above, through purchasing blocks of time. Prices quoted are for three or six hours of work respectively, unless otherwise stated, and exclude VAT. The service will be provided by Exeter Diocesan Education Team and/or Associates.

### Headteacher Performance Management

#### This will include the following:

- ✓ Preparation including a review of the last year's evidence
- ✓ Pre-meetings with the Head and performance management committee members
- ✓ A written statement outlining the review of evidence, targets for improvement and agreed professional development
- ✓ Preparation for the end of year review meeting
- ✓ Advice and support for the end of year review meeting
- ✓ A finalised written review statement
- ✓ Interim visits can also be offered, subject to an additional charge

### Appendix 1: Our Core Offer



Exeter Diocesan Board of Education, through its officers, provides all its church schools with a range of services which form the core level of support. Our core work is determined by the Diocesan Board of Education Measure 2021, which can be viewed <a href="https://exemple.com/here.">here.</a>

This support is paid for by the Exeter Diocesan Board of Finance and includes:

#### Leadership and Management, including Governance

- ✓ A DMAC (Diocesan MAT annual conversation) at least once every two years with trust leaders.
- ✓ Free attendance at Exeter MAT Leadership Forum.
- ✓ In Church Secondary schools, a full day 'Critical Friend Review' at least once every three years, to support strong working relationships and effective partnerships with our Secondary schools and Academies.
- ✓ Free attendance at termly Leadership forums (These are for Senior Leaders and will usually be virtual meetings).
- ✓ Free attendance at termly Governance forums (For all those involved in school/academy Governance usually held by video conference meetings).
- ✓ Church school Executive Headteacher, Headteacher or Head of School recruitment information pack and planning visit for the Governing Board from a member of the Education Team (or Associate). It is expected that governors consult with Diocesan staff on Executive Headteacher, Headteacher and Head of School appointments in former VC and VA schools.



- ✓ Support with CEO appointments (consultation with the Diocesan Board of Education is required) and attendance at shortlisting and interviews.
- ✓ Attendance of up to one day at interviews to support the appointment of an Executive Headteacher/ Headteacher / Head of School within a trust (Subject to appropriate consultation and agreement of dates with the Diocese).

- ✓ Induction day, at the Old Deanery, for all new church school senior leaders to introduce the team, build networks and share key information regarding church school leadership.
- ✓ Resources (and facilitation if required) for a commissioning service for new Heads.
- ✓ Monitoring the performance of schools through published performance data; liaising with local authorities and the Regional Delivery Directorate with regard to church schools; and providing additional support to RI schools and those in Ofsted categories.
- ✓ Additional support for schools judged to be less than good by SIAMS.
- ✓ Pastoral support for CEOs, Executive Headteachers, Headteachers, Heads of School and Chairs of Directors.
- ✓ Attendance at Ofsted and SIAMS Inspection feedback, subject to invitation and availability.
- ✓ Advice with regard to the recruitment and appointment of Foundation representation on Governance Boards.
- ✓ Advice for Governance Professionals/Clerks to support compliance with statutory responsibilities.
- Church School Induction training for Directors and those involved in local governance on what it means to be involved in governance in a church school and the responsibilities.
- ✓ Signposting of peer-to-peer support for new Chairs by facilitating partnership with more experienced Chairs, if required.
- ✓ Director/Governance training and support on effective governance with a particular focus on the monitoring of Christian Distinctiveness (if requested as part of our pre-SIAMS preparation visit once in every SIAMS cycle).

#### **Admissions**

- ✓ Admissions guidance to support compliance with statutory responsibilities.
- ✓ Admissions training (1/2 day) for staff and Governing Boards involved in admissions.
- ✓ An annual admission update meeting.

#### **School Structures**

- ✓ Guidance on your statutory responsibilities in relation to changes to the status, size and age range of schools.
- ✓ Liaising and supporting MATs who are considering a Management Partnership.
- ✓ Attending Management Partnership joint committee meetings, when required.
- ✓ Supporting schools who are looking to convert to academy and helping Trusts ensure these school(s) understand what this means in reality.
- ✓ Supporting Trust in explorations when considering 'coming together' with other MATs (transfer, closure, expansion).

#### **Religious Education, Collective Worship and SIAMS**

- ✓ We offer a free pre-SIAMs preparation visit (we're working towards these being mid-cycle).
- ✓ Free attendance at termly SIAMS hub meetings. These are generally virtual meetings held on a termly basis.
- ✓ Free attendance at termly locally held LTLRE (Learn, Teach, Lead, Religious Education) meetings.

## Appendix 1: Our Core Offer

#### **School Buildings and Land Issues**

The following core services are provided for Church Academies through the Diocesan Property Services Department:

- ✓ Technical updates and guidance on changes in premises matters and capital funding using the Premises Advice document (accessed on the Diocesan Website).
- ✓ Grant Funding Advice When requested, Diocesan Surveyors will advise as to capital grant funding opportunities that may be available to Church Academies at that time.
- ✓ Representing Church Academies (as a group) in the development of capital programmes and funding where appropriate and working alongside the relevant LA, DfE/ESFA and other partner providers and stakeholders.
- Representing Church Academies at Local and National Government level where appropriate, and liaising with Local Authorities, the DfE/ESFA and the National Society in addressing building and capital funding issues affecting Church Academies (as a group).
- ✓ Working with LAs in developing Service Level Agreements suitable for Church Academies where appropriate, to assist them in developing maintenance/SLA packages for offering building services and statutory inspections etc which may benefit Academy Trusts in meeting their legal and health and safety responsibilities.
- Developing Practical Links with Other Religious Faiths/Traditions where appropriate on educational and premises issues and which can achieve better solutions for all, at better value, and will help foster good ecumenical relations.
- ✓ Reacting to Unexpected/Disastrous Occurrences where Building Premises are involved by providing practical, financial and moral support to the Church Academies as required.

The following services are currently made available to Church Academies through EDPS Ltd on a separate professional fee basis (to be separately agreed and dependent on specific commission):

- a) Premises Advice to Church Academies on specific matters.
- b) Assisting Academies in obtaining legal advice on Building Contractual Issues The Officers will support Church Academy Trusts in legal disputes which arise where the Directors have followed specific advice provided by the Diocese.
- c) Land Transfer / Purchase / Disposal Officers can assist Trustees and Church Academies with land transfer and purchases. Services include liaison with Trustees, solicitors, LAs and other associated agencies.
- d) Asset Management Plan advice when requested.
- e) Providing Premises Advice to Academies regarding Nurseries / Pre Schools / Community Use etc on Church Academy sites and liaising with the Trustees, the LA, solicitors and private providers in relation to leases, hiring agreements etc.
- f) Reacting to Unexpected/Disastrous Occurrences where Building Premises are involved at Church Academies, providing practical and technical support where appropriate.

#### **Communication and additional benefits**

- ✓ Initial telephone and video-conference support from the Education Team; when you need it.
- ✓ Fortnightly 'Flourish' newsletter with up-to-date advice and guidance and signposting to useful resources.
- ✓ Access to the EDBE website with information and guidance relating to Church schools.

# Training and Development

In addition, the Education Team will **advocate and act on behalf** of our Diocesan family of schools through:

- ✓ Our national and regional diocesan networks;
- ✓ Our close links with the Church of England Education Office and the wider Church;
- ✓ Our contacts with the DfE's Regional Delivery Directorate; and Regional Director's office;
- ✓ Our association with the Teaching School Hubs and national NPQ providers;
- ✓ Our partnerships with Local Authorities; and,
- ✓ Our links with clergy and church teams across the Diocese.

We offer a diocesan funded comprehensive training programme to ensure that we enact our vision and meet our statutory responsibilities. We also offer open access to our costed training courses, conferences and consultancy arranged by the Education Team and the wider diocesan networks.

The Core Service, including these free courses, are funded by the Diocesan Board of Finance Your purchase of the SLA subscription service supports your Trust and schools specifically yet also contributes to the staffing of the Diocesan Education Team, enabling us to provide a service to meet your needs and support the diocesan family of schools as a whole. 
