## A new SIAMS Framework - September 2023

SIAMS inspection plays an important role in the improvement of Church schools. It does this by affirming that which is effective and by highlighting key areas for improvement. The new Framework, being implemented from September 2023, is being described as 'radically different, radically the same'. The work of schools should not need to change (though please be aware of the Framework expectations), however the work of inspectors will be different. For example, inspectors will place a sharper focus on vision and on understanding your school's context and why you are doing what you do. Whilst SIAMS remains an inspection of an individual school, trusts will be held to account through SIAMS inspection for their responsibilities for Church schools.
